#### CALL TO ORDER

Chair Councilwoman Fox called the meeting to order at 1:00 PM. Ms. Watkins confirmed that the requirements of the Freedom of Information Act were fulfilled, and the meeting agenda was properly posted.

#### APPROVAL OF MINUTES

1. Ms. Fox reviewed the minutes. As there was no discussion, Ms Carter made a motion to approve the minutes from the meeting of July 28, 2022, which was seconded by Mr Phillips. The motion for APPROVAL was unanimous.

#### **NEW BUSINESS ITEMS**

- 1. **Community Promotion Grants Applications:** Kiawah Seabrook Exchange Club Foundation

The committee requested two additional flags to be purchased by the Kiawah—Seabrook Exchange Club to be flown at Seabrook Island Town Hall in addition to current locations.
