Lynda forwarded your Temporary Use Permit application to me. Before this goes to Town Council for review, we will need a copy of your COVID protocols for this event. Our current emergency ordinance allows the following:

"Town Council may consider requests for temporary use permits for events and activities... Any gathering requiring a temporary use permit shall be subject to all applicable provisions contained within... this Ordinance... The Town Council may approve the issuance of a temporary use permit if it determines that the organizers or sponsors of the event or activity will undertake reasonable measures to minimize the risk of spread of COVID-19 within the Town in consequence of such event or activity."

Before this is presented to council, we will need you to supply your COVID protocols for this event. I have attached samples from two other events.
