## 2021 Bohicket Invitational Billfish Tournament

This copy signifies the precautions Bohicket Marina will be taking due to Covid-19 in organizing our annual Billfish Tournament.

It will be announced that the tournament will be a private tournament closed to the public. This will reduce the amount of spectators visiting. Masks must be worn during all interactions between staff and participants. Hand Sanitizer stations will be placed throughout the marina. Tables around the fountain will be properly distanced in case they are utilized by participants.

### Captains Meeting:

- The captains meeting will be done via Facebook Live or Zoom and will not be open to the public.

### Crowd Management:

- Ten wristbands will be provided to each participating boat. Only those with wristbands will be allowed on the docks. The sheriff's office will be at the entrance to the main fishing docks to allow only wristband holders to pass.
- The boardwalks will be blocked off from outside spectators and will only allow captains, crew and anyone with an approved wristband to occupy boardwalk.
- Weigh in will be streamed on Facebook Live & markers will be put where participants must stand while waiting for their catch to be weighed.
- Gathering of participants on the docks will be addressed when seen. All participants will be encouraged to practice safe distancing.

### Vendors:

- Vendor booths will be properly distanced from each other and will only allow 2 people per booth at a time.

### Event Dinner:

- There will not be a dinner gathering for the participants. However, Salty Dog will be providing dinner delivered to the boats each night around 7:30-8pm. There will be limited interaction between the deliverer and recipient during this process. Masks will be worn during delivery. Salty Dog will be working with an online ordering system in order to reduce interaction with participants.
- There will be an open bar, however, there will be markers to indicate where participants must wait in line & must have their wristbands and masks on.

### Awards:

- The awards ceremony will be streamed on a Facebook Live and will not be open to the public.
